



Instructions for authors

Papers have to be submitted in **Czech, Slovak or English language**. First it is necessary to submit a title of the paper in electronic form via the conference website.

Completed papers should be submitted afterwards in the appropriate format. All the accepted papers will be **reviewed** after conference. Conformance to standards of ethical behaviour is expected.

A submitted paper overall length: **6 pages** including results, figures, tables and references. For detailed information, instructions for authors and templates visit the webpage:

After successful review will be **selected papers in English language** offered to the main conference proceedings which will be submitted to **Thomson Reuters** for evaluation (proceedings from 2015 is already **indexed in Web of Science**).

Other papers in Czech and Slovak language accepted by reviewers will be published in secondary proceedings on the conference CD with special ISBN. Both proceedings will be sent to participants after the conference.

- Deadline for the submitting of a **title** of the paper is **October 31, 2017**
- Deadline for the submitting of a **full version of the paper** is **November 20, 2017** (after the conference)
